ACCESSIBILITY: Bill S.

The Accessibility Committee met on March 28 via phone. In Attendance: Bill Sx and Lisa H. Meeting began at 2:00 PM.

Discussed a concern with liability if drivers and in-home meetings were sponsored by the Accessibility committee. GSP will be contacted on this issue to deterge if there is any problem.

Lisa provided her experience with Accessibility Committees in two different districts. We are looking forward to incorporation Lisa's experience with our committee.

Bill S. and Sarah N. attended the Accessibility Committee meeting at the April quarterly. Mostly discussed the April Conference issues to provide support of our Delegate. Also discussed was the lack of an American Sign Language interpreter at the quarterly A member had requested ALS support for this quarterly and was most disappointed that there was none., This person is deaf and severely affected by the lack of an ALS interpreter. A lengthy discussion with the deaf member who used lip reading to understand what we were saying was a most enlightening experience. In brief, here are some of the things we learned about people who were born deaf or became deaf at early childhood:

- An ALS interpreter is a MUST for the deaf
- The ALS interpreter needs to be seen from head to toe
- A subtitle presentation of what someone is saying is not acceptable for the deaf
- Reading the Big Book and other literature is NOT an option for the deaf as the vocabulary used is beyond some deaf people's comprehension.
- The Big Book and Twelve and Twelve are available for the deaf in a video presentation of an ALS interpreter, but no other documents are available in this format

It has been determined that ALS services are available locally at a minimum cost of \$140 for 2 hours and \$70 for each hour thereafter. GSO does not fund this for meetings. If a group is not able to support this cost by the contributions received, a separate collection is recommended. The Accessibility Committee will investigate funding sources to provide ASL interpreters for District and Intergroup events as well as at some A.A. meetings.

More will be revealed.
