OLD BUSINESS

- Costs for renewals for Our Meeting in Print were reviewed. (*10 LaVina, 20 Grapevine- to be distributed to CCJ Men's, CCI, 2-3 to Work Camps, and so forth.)
- Chaplain Dietl is no longer the Chaplain for Arcadia. No explanation was given, so Asst. Moody will be filling in. Also, of note, the Warden of Security position remains vacant, as Warden Murphy has been reassigned to a District Director position.
- Please note, the Processing Procedures for CCJ AA Volunteers has been updated. Lt. Long, Support Services Commander, is now OVER-ALL HEAD of THE Volunteer Program. (attached)
- The updated volunteer list for the Men's jail was completed and is attached.
- Flow charts for the AA Pre-Release Program for prison inmates, and the AA Bridging -the-Gap Program for treatment patients, has been delayed. JJ will be handling this in the coming month. This effort is to clarify for the AA Volunteers, at the Intergroup Office, who get phone calls from the various agencies for appropriate referrals.
- E-mails were, again, sent to probation depts. regarding our services from AA. And, again, there has been no response. It will need to be personally followed up on in the future, as our volunteers are able.
- Whether an AA meeting will be started again at the Arcadia jail is pending. And Les H. stated Jail personnel have our info. And can access it when they see the need.
- Men's CCJ AA Meeting list coverage was completed (attached)
- All old Corrections Committee info. With personal information from pervious Committees has been shredded. This was for Expediency and confidentiality.

NEW BUSINESS

- JJ A. reviewed the Area 15 Corrections Com. Meeting at this past Area Assembly. Tablets for Inmates appear to be all over the DOC. However, many questions remain to be sorted out, among them: how does the hardware really work; does the inmate pay for them; when will they be fully functional; what can be received/sent, etc. The Committee elected a new chair and secretary, but no alt. chair stepped up.

Welcome to our new Accessibility Committee member Mary P. Mary brings her experience with the deaf and hard of hearing community.

The effort of the Accessibility Committee and the Intergroup Events Committee to provide American Sign Language support of the dinner was rewarded with the 4 attendees who benefited from the ASL interpreters. This is the first time that ASL was used at a District 5 dinner in helping carry the A.A. message to the deaf and hard of hearing. This required the support of 2 interpreters and a discounted fee of \$325. This was money well worth spending as the joy of these 4 attendees was most evident.

As a result of the success of carrying the A.A. message to the deaf, the Accessibility Committee has requested that a separate budget line item be funded for the 3 dinners scheduled for 2019 in the amount of \$1000.
