## Alcoholics Anonymous publishes first new book in 30 years: Our Great Responsibility

The first original title released by Alcoholics Anonymous in more than 30 years, the book Our Great Responsibility: A Selection of Bill W.'s General Service Conference Talks, 1951–1970, is now available in English, French and Spanish.

Bill W. addressed the Conference on an annual basis over the course of two decades prior to his death in 1971. Our Great Responsibility gathers many of these talks, capturing Bill's innovative thinking on myriad A.A. themes. The book includes:

- 16 talks derived from archival audio recordings offering fresh perspectives on A.A. in the cofounder's own words
- More than 60 archival photos and other images
- Previously unpublished material from the A.A. General Service Office Archives

With Bill W. as its primary architect, A.A. developed a loosely organized service structure that eventually succeeded the direction and guidance of its founders to provide enduring leadership for the Fellowship as a whole.

Launched in 1951 and meeting annually ever since, A.A.'s General Service Conference has been the primary mechanism for an increasingly diverse membership to deliberate and determine its "group conscience" on a wide range of matters affecting A.A. as a whole.
