DISTRICT 5 Area 15 REPORT

District 5 supports approximately 44 meetings per month in 5 institutional settings. Desoto Correctional Institution Amoex in Arcadia, DCI Work Comp in Arcadia, Charlotte Correctional Institution in Punta Gorda, CCI Work Comp in Lee County and Charlotte County Jail in Punta Gorda.

Over the past Two months we have seen an increase in interest by AA members in Corrections efforts of the District committee carry the message inside the walls. Several have applied for electronic and have been approved both at The county and state facilities. We hope this increase in the Committee numbers will enable us to spread our efforts and possibly help restart a meeting in Desoto County Jail, which was discontinued. All the Road Camps have been closed except for two which are not in our district, by direction of the state.

The committee participated in a phone conference with the Corrections Desk at G50 and a member of the committee there working digital issues with Tablets and digital access by inmates to AA literature in digital format we provided our insight, experience and pointed out our difficulties with working in a "closed informational" setting. G50 continues to work on this and we are waiting for a progress report this week from David R. of that committee at G50, who is working with the service vendors.

We look forward to doing more this year with the increased level of help from the fellowship. The district continues to provide excellent financial support and our members inside are appreciative. Several have been released and the Fre-release program is working well, as is the Correction Correspondence Program. We continue to

support the Three groups at DCI with Literature as well as the groups at CCI and the Charlotto County Jail, with Grapevines and other materials as permitted. The DCI Monday Group has begun to compile a list of housing and halfway house availability for their members to help with those issues for inmates.
