#### Correction Facilities - John A.

Our District 5 Corrections committee continues to sponsor 40 AA meetings in three institutions at 4 locations in our district. We provide 6 meetings per week at the DeSoto Correctional Institute in DeSoto County including 3 on Monday with a Spanish speaking meeting, a meeting in the chapel, and a meeting at their work camp. On Tuesday there is an additional meeting in the chapel, on Wednesday there is a meeting for veterans, and on Thursday there is a meeting in A Dorm. We have a significant need for volunteers. We have a few new volunteers who are recently approved and are being introduced into the schedule with veterans to show them the ropes. We also just added one who speaks Spanish which was a huge need. When you total up the average attendance at these meetings, we are thrilled that we impact nearly 160 inmates per week when we include all meetings once. We are potentially changing lots of lives for the better. Join us!

In addition to the meetings at DeSoto we provide one meeting per week on Monday at the Charlotte Correctional Institute and an additional meeting on Saturday at their work camp. We have recently learned that progress is being made with their expansion so the numbers should improve soon. We also welcomed two new members this past week.

We provide two meetings per month at the Charlotte County jail, one for women and one for men. The men's meeting has grown significantly lately and the women's is consistent.

We continue to seek volunteers to sponsor inmates to work the steps with them. Meeting sponsors are not permitted to do that kind of one-on-one work as we are there for the entire group. We have several inmates currently waiting for someone to work with them. The requirements for doing this work are not nearly as stringent as far as background checks etc as for meeting sponsors. Our pre-release program continues to go well. We have set up several released inmates with an outside contact to get them plugged into the program on the outside.

At our monthly meeting on the 13th, we discussed two upcoming events: Our joint Area 14 & Area 15 Corrections workshop will take place on Sunday, September 21st at the ODAT Club (Pine Island Group) in Orlando from 1:30 until 4:30. Several panels will discuss ongoing correction successes and challenges. This meeting will be hybrid so anyone can join. Access codes to attend via Zoom are 847-3048-2501 with a password of 984923. This conference was a big success last year and food and drinks will be served to entice person participation. There will also be a National Corrections Conference in Nashville from November 7th to 9th. I have registered to attend.

#### **New Business:**

Corrections Committee Motion for a Supplemental Budget Request

The Corrections Committee requests a supplemental budget in the amount of \$1,500 to cover anticipated needs for the balance of this year. There are several factors that necessitate this increase:

- · A significant increase in the population being served at DeSoto
- The new meeting we started at the work camp for Charlotte Correctional.
- · An increase in the use of literature in most of our meetings. We have replaced most discussion meetings with literature meetings to better concentrate on recovery as opposed to random discussions.
- · An increased need for Spanish literature due to both population increase and literature focus.
- · Increased cost of literature in general.
- · Increased cost of supplies provided such as coffee.

I would also request reimbursement for part of the cost of attending the National Corrections Conference in Nashville in November. In following our tradition of supporting one night hotel reservation and the cost of a banquet, I am requesting that and the cost of the conference itself. The amount for the room is \$181.14 and the conference cost is \$150.00 for a total of \$331.14. This request would be covered by the total request of \$1500.00.

A motion was made by John and PASSED WITH ALL IN FAVOR of increasing the corrections budget.

A motion was made by Jay Jay to purchase a computer for the District Treasurer position. The computer cost cap

was set at \$1000 and would include the purchase of the software program QuickBooks to be used on the computer. An additional \$1000 for the purchase of a new computer for the secretary position shall stay in reserve until the start of the next term.

THIS MOTION PASSED WITH ALL IN FAVOR.
