District 5 Corrections Report

November 2025

Our District 5 Corrections committee continues to sponsor 40 AA meetings in three institutions at 4 locations in our district. We provide 6 meetings per week at the DeSoto Correctional Institute in DeSoto County including 3 on Monday with a Spanish speaking meeting, a meeting in the chapel, and a meeting at their work camp. On Tuesday there is an additional meeting in the chapel, on Wednesday there is a meeting for veterans, and on Thursday there is a meeting in A Dorm. We have a significant need for volunteers. We have a few new volunteers who are recently approved and are being introduced into the schedule with veterans to show them the ropes. We also just added one who speaks Spanish which was a huge need. When you total up the average attendance at these meetings, we are thrilled that we impact nearly 160 inmates per week when we include all meetings once. We are potentially changing lots of lives for the better. Join us!

In addition to the meetings at DeSoto we provide one meeting per week on Monday at the Charlotte Correctional Institute and an additional meeting on Saturday at their work camp. We have recently learned that progress is being made with their expansion so the numbers should improve soon. We also welcomed two new members this past week.

We provide two meetings per month at the Charlotte County jail, one for women and one for men. The men's meeting has grown significantly lately and the women's is consistent.

We had our regular monthly meeting on Saturday which was attended by 9 volunteers. We will have some scheduling issues for December as JJ, who handles the Spanish and the Vets meetings every week, will be away for 2 weeks. We are looking for volunteers to step up and take some extra meetings to fill the gap. Attendance at all of our meetings continues to grow and we are grateful that the work has spread that we are there to help and that there is hope in our program. Many thanks to our outstanding volunteers who are carrying that message to those unable to access it due to their circumstances.

We continue to seek volunteers to sponsor inmates to work the steps with them. Meeting sponsors are not permitted to do that kind of one-on-one work as we are there for the entire group. We have several inmates currently waiting for someone to work with them. The requirements for doing this work are not nearly as stringent as far as background checks etc as for meeting sponsors. Our pre-release program continues to go well. We have set up several released inmates with an outside contact to get them plugged into the program on the outside.

I attended the National Corrections Conference in Nashville. It was both informative and inspirational. The chair was a former "lifer" in Tennessee and his story, along with others who spoke, reinforced the potential for changed lives the work we do can help produce. A former warden and DA also helped reinforce the positive results of what we are so blessed to do. Part of the message from the DA was the fact that, once incarcerated, the public forgets these people and, while some are probably not redeemable, most are if given the right opportunity. He also recommended, when having access resisted

to our requests for access, we start at the top and avoid the “gatekeepers” where possible as each adds a layer of interference that we need to overcome.

I am pleased to announce that our bid to host the 2027 conference here in Florida was accepted. As is typical in AA we went through several votes and, while we had a plurality in each vote, we failed to get the 2/3 majority required so we “went to the hat” and won. Next year we will be in Salt Lake City and then the real work for us will begin.
